ORDER


WHEREAS, O.C.G.A. 15-11-50 provides that Juvenile Court Judges shall exercise circuit-wide jurisdiction; and

WHEREAS, Joey M. Loudermilk is at least thirty (30) years of age, has been a citizen of this State for at least three (3) years, and has been practicing law within the Chattahoochee Judicial Circuit for at least five (5) years, and therefore is qualified to serve as a Juvenile Court Judge with regard to the requirements of O.C.G.A. 15-11-51, and


NOW, THEREFORE, pursuant to the authority vested in us as Judges of the Superior Courts of the Chattahoochee Judicial Circuit pursuant to O.C.G.A. 15-11-50, it is hereby Ordered and Decreed as follows:

1. Joey M. Loudermilk, presently of Ellerslie, Harris County, Georgia, is hereby appointed Judge of the Juvenile Courts of the Chattahoochee Judicial Circuit, to a position formerly held by Judge Wayne Jernigan until his retirement and expiring on June 30, 2014.
2. As Judge of the Juvenile Courts of the Chattahoochee Judicial Circuit, Warner L. Kennon, Andrew C. Dodgen and Joey M. Loudermilk shall exercise circuit-wide jurisdiction, with all Juvenile Court proceedings in the following counties assigned to them for disposition: Muscogee, Harris, Talbot, Taylor, Marion and Chattahoochee Counties.
3. Warner Kennon's status as Juvenile Court Judge shall continue to be full-time.
4. Warner Kennon shall continue to be designated as the Presiding Judge.


